The 2-year guarantee period starts as soon as you receive your goods. If a defect becomes apparent within 1 year of delivery, you don't have to prove it existed at the time of delivery. It is assumed that it did unless the seller can prove otherwise. This warranty does not apply to normal wear and tear or damage caused by negligence, lack of maintenance, accident, abnormal operation, improper. This standard outlines the construction requirements, testing methods, and performance parameters for cable trays and related support systems.
